## New Normal Protocol Terms & Conditions

- 1. I agree to comply with all Boca Rica's policies and rules, including but not limited to all Boca Rica's new normal policies, guidelines, signage, and instructions.
- 2. I agree that I am personally responsible and accountable for my safety and actions within Boca Rica's premises.
- 3. I agree that Boca Rica is open for public and have taken measures to meet the standards of new normal and follow recommended protocols provided by the local government.
- 4. With full awareness and appreciation of the risks involved, I, for myself and on behalf of my family, spouse, estate, heirs, executors, administrators, assigns, and personal representatives, hereby forever release, waive, discharge, and covenant not to sue Boca Rica, its board members, officers, agents, servants, independent contractors, affiliates, employees, successors, and assigns (collectively the "Released Parties") from any and all liability, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, related to COVID-19 whether caused by the negligence of the Released Parties, any third-party using Boca Rica, or otherwise, while participating in any activity while in, on, or around Boca Rica and/or while using any Boca Rica facilities, products, equipment, or materials.
